We heard about the 1st confirmed COVID case in the U.S. in late January around the time WHO declares a global health emergency. Late February bring the 1st case of local transmission in the U.S. and less than a week later it is reported the 1st death in the U.S. It's official, there is a coronavirus pandemic sweeping the nation. All the while we looked for advice and direction from our leadership at the national level of ADHA. They gave us recommendations from the CDC, OSHA, ADA and OSAP, in order to protect us, the dental team and our patients.

By mid-April there was finally news from the Governor that we could reopen dental offices. What do we do now? There was a panic to get PPE (N-95 respirators, KN-95 masks, face shields, hair coverings, shoe coverings, gowns, neck coverings, hazmat suits, goggles, etc.), air purifiers, UV lights, plexiglass shields, hand sanitizer, signs (maintain 6 feet social distancing, wear a masks, and "How to prevent the spread of COVID?") just to name a few. Some offices didn't hesitate to open and others waited until they had new protocols and policies and procedures in place. Some of you were openly scared about what to expect upon returning to work, some of you retired because of COVID, some of you left the field of dentistry and some of you embraced the changes that we had to face. I hope that whatever your choice was, if you are still in the field of dentistry, that you are feeling more comfortable having been back in the office now for almost 3 months with our new "Normal."

So, where do we go from here? We keep moving forward as an organization even though it may be just virtually for now. We continue to support one another through these uncharted waters and continue to look for guidance and leadership from ODHA and ADHA, who supported us and led the fight to protect us, its members. Now more than ever, our numbers are very important, so try to recruit a friend or colleague. It's especially easy now because everything is virtual. Support TDHA's officers and upcoming CE's. Stay connected, call or text someone you haven't seen or heard from in a while.

We have no idea what the future will bring but let us hope that 2021 is **NOT** a repeat of 2020. Only time will tell. As Mahatma Gandhi once said, "The future depends on what you do today." Stay safe and practice smart!

Course Description

The Ohio State Dental Board requires mandatory opioid prescribing continuing education for dentists and dental hygienists. This virtual course is approved and in compliance with the re-licensure continuing education requirement. The course will discuss opioid and non-opioid pharmacologic therapy. The mechanism of action, pharmacologic effects, and adverse effects of commonly prescribed medications will be reviewed. Addiction and chronic administration will be covered. The course will discuss addiction treatment and medications used to assist addiction treatment. Considerations for dental prescribing of opioids along with assessment of current and potential signs of drug abuse will be considered. The course will conclude with a question and answer session.
